

Terms and Conditions for “Action Ka Saval”, “Purani Yade Aapke Saath”, “Gold Crystal Contest”, “Bumper Of Bollywood” and “Music Master” Contests

The following terms and conditions shall be applicable to the contests (hereinafter may be collectively referred to as “**Activity/Contests**” and individually as “**Contest**”) conducted by GTPL Hathway Limited (“**GTPL**”) on-air on GTPL owned television channels namely, GTPL Action, GTPL Retro, GTPL Gold, GTPL Cinema and GTPL Music (Hereinafter collectively referred to as “**Channels**” and individually as “**Channel**”). The Contests are listed below as follows:

Each Contest shall function in a manner as specified in Specific Terms and Conditions (“**Specific T&Cs**”) of the respective Contest at the end of General Terms and Conditions for the Activity (“**General T&Cs**”/ “**General Terms and Conditions**”).

The terms and conditions of the Activity have been divided as follows:

- (A) General T&Cs
- (B.1) Specific T&Cs for Action Ka Saval.
- (B.2) Specific T&Cs for Purani Yade Aapke Saath
- (B.3) Specific T&Cs for Gold Crystal Contest
- (B.4) Specific T&Cs for Bumper Of Bollywood
- (B.5) Specific T&Cs for Music Master

(A)General Terms and Conditions

1. Eligibility

- 1.1 The Activity is open only to Indian citizens, residing in India. Citizens and/or residents of other countries are not eligible to participate.
- 1.2 The Participants must be adults having attained the age of eighteen (18) years to participate in the Activity as on the date of the Activity.
(All persons fulfilling conditions mentioned in sections 1.1 & 1.2 shall be hereinafter referred to as “*Participants*”)
